The COVID-19 pandemic and Public Health Emergency may have been declared as "over" but the long-term effects of the pandemic remain with us. The MN Department of Health has secured funding to understand the impacts and raise awareness of long COVID and post-COVID conditions.

Paxlovid has been approved by the FDA for mild-to-moderate COVID-19. The question of crushing Paxlovid remains a challenge for many of our seniors that need their medications crushed. This article addresses off-label use (crushing) and how it impacts us as prescribers.

Case: A 76-year-old woman is new to you in your LTC after TCU stay posthospitalizations for recurrent GI bleeds due to NSAID-induced esophageal and gastric ulcers. A few topics to share with MAGIC members from the May 31 meeting are included here:

PALTC Foundation Awards

The Foundation for Post-Acute and Long Term Care Medicine sponsors four awards each year. Nominations opened July 1 for the following 2024 Excellence Awards:

- Clinician of the Year Award
- Medical Director of the Year Award
- William Dodd Founder's Award for Distinguished Service
- James Pattee Award for Excellence in Education

The Clinician of the Year Award recognizes members of the interdisciplinary (IDT) team who serve in

PALTC settings. It honors a licensed health-care practitioner who is directly involved in treating and caring for people in PALTC settings and who embodies excellence in patient/resident care.

The Medical Director of the Year Award recognizes those individuals whose vision, passion, leadership, knowledge, and commitment succeed in taking patient care to exceptional levels of quality, excellence, and innovation

The William Dodd Founder's Award for Distinguished Service recognizes significant contributions to building the Society's organizational strength, image, and mission by promoting the development of competent, compassionate, and committed medical practitioners.

The James Pattee Award for Excellence in Education recognizes significant contributions to enhance the Society's educational structure and framework, to advance education specific to PALTC practice, and to promote AMDA leadership via educational endeavors within the LTC continuum. It was established to honor James Pattee, MD, CMD, the father of the AMDA Certification Program and the Core Curriculum program. Dr. Pattee was a geriatrician and medical director right here in in Minnesota!

PALTC24 – delegates and resolutions

Speaking of PALTC24 - Start planning for AMDA's annual conference, which will take place March 9-12 in San Antonio, Texas.

We encourage MAGIC members to think about whether you would like to be a delegate from our chapter to the House of Delegates.

It's not too early to think about resolutions for 2024. The process for bringing forward resolutions at AMDA, with the goal of bringing them to the House of Delegates for voting at the annual meeting, was reviewed. Resolutions give AMDA direction and priorities from the membership. Examples of prior years' resolutions can be found <u>here</u> and include topics such as oversight of PRN psychotropic drugs for hospice patients in SNF/LTC; advocating for a waiver process for regulatory visits to be able to be done via telehealth; and supporting efforts to increase transparency in nursing home ownership.

New medical director requirement for LTC facilities passed in California

Attendees at the Open Mic Meeting learned about California AB 749, Skilled Nursing Facilities: Medical Director Certification, which was signed into law in late 2021.

As required by California Legislation (<u>Assembly Bill No. 749</u>), all nursing home medical directors* in California must be certified by the American Board of Post-Acute and Long Term Care Medicine (<u>ABPLM</u>). AB 749 will help ensure that every medical director in California is prepared to provide effective oversight of quality and safety in their nursing homes. A medical director already employed in a skilled nursing facility as of January 1, 2022, has five years (until January 1, 2027) to become a Certified Medical Director. (*See <u>AB749</u> for complete details and exemptions.)

Implementing this legislation will require the development and maintenance of a California state registry of medical directors. Advocating for this type of registry in Minnesota is being discussed by the MAGIC board. Paxlovid Update

Paxlovid now has full FDA approval!

- No longer governed by EUA Emergency Use Authorization rules
- What does that mean for us as prescribers?

Per the FDA's press release on May 25, 2023:

"Today, the U.S. Food and Drug Administration approved the oral antiviral Paxlovid (nirmatrelvir tablets and ritonavir tablets, co-packaged for oral use) for the treatment of mild-to-moderate COVID-19 in adults who are at high risk for progression to severe COVID-19, including hospitalization or death." The FDA used data from the EPIC-HR trial, which was a randomized, doubleblind, placebo-controlled clinical trial studying Paxlovid for the treatment of non-hospitalized symptomatic adults with COVID-19, who were unvaccinated and had no prior immunity to COVID-19; and who had a prespecified risk factor for progression to severe disease or were 60 years and older regardless of prespecified chronic medical conditions. Another part of this trial looked at those who were antibody positive for COVID; and another trial (EPIC-SR) studied vaccinated patients with one or more risk factor for progression to severe disease. Hospitalization and death was reduced in these groups as well, though not by as much.

These trials also looked at whether Paxlovid was associated with rebound COVID symptoms, and found there was a similar rate of rebound symptoms in the Paxlovid group and the group that received placebo. This argues against the idea that Paxlovid causes more rebound COVID-19.

TOPICS reached out again to Dr. Jessica Zering, pharmacist in the Washington State Department of Health, who gave us such good guidance in our February issue about the importance of not crushing Paxlovid while under EUA. Per Dr. Zering, "The FDA approval is only for the treatment of mild-tomoderate COVID-19 in adults at high risk for severe disease, including hospitalization and death." (Use in children ages 12-17 with increased risk remains under EUA).

When it comes to the question of heing able to crush the nills Dr Zering

states, "The language advising against crushing the tablet is still in the package insert. The rationale for this is due to a lack of pharmacokinetic/pharmacodynamic data for crushed tablets." Crushing the tablets would be an off-label use; Dr. Zering advises following institution policy or best practice regarding off-label medication usage.

In the absence of institutional policies, if considering this off-label use of approved medication, it may be reasonable to consider such things as informed consent; potential benefit vs potential risk; clinical judgment; and available evidence. One monograph entitled "Therapeutic Brief: Crushing Nirmatrelvir/ritonavir (Paxlovid)" summarizes some pharmacokinetic data and can be found <u>here</u>. This monograph is by the British Columbia COVID Therapeutics Committee COVID Therapy Review and Advisory Working Group, and is dated July 4, 2022. It states, "Both ritonavir and nirmatrelvir (components of Paxlovid) *can be split or crushed and mixed with apple sauce, pudding or any common food or liquid* including dairy-containing products based on Phase I studies demonstrating that suspensions achieve similar pharmacokinetics to whole tablets." More detail of the available data and thoughts about clinical judgment can be found in the monograph.

MDH's Long COVID Work

Kate Murray, Program Manager for Long COVID & Post-COVID Conditions at MDH, shared the following update:

The Minnesota Department of Health (MDH) is working to understand the impacts of long COVID and post-COVID conditions on people in Minnesota and support those most affected. The program's efforts include increasing awareness about long COVID and available resources, convening a Guiding Council of clinicians who care for people with long COVID, conducting phone surveys, partnering with community organizations around messaging and needs assessments, and engaging people with long COVID and their caregivers to help inform efforts and priorities. Thanks to new State funding, the program will soon be able to expand and sustain this work and the partnerships that are central to it.
